TYPICAL PROPERTIES

As supplied, Citrus 6000 is slightly alkaline in nature.

This aspect is important when being used as a degreasing agent, however this is rendered almost neutral when diluted for surface cleaning; which is typically diluted to around 10 or 20 parts water to one part Citrus 6000.

Natural d-limonene is a key ingredient in Citrus 6000 and allows it to be used in so many cleaning and degreasing applications.

What sets Citrus 6000 apart from the myriad of other so called citrus cleaners is its high concentration and the genuine inclusion of d-limonene (as opposed to the simple use of citrus fragrance). Commonly citrus cleaners have often been labelled "citrus" when in fact they contain little or no d-limonene whatsoever.
