
Installation Instructions for 16X664 and 16X665 Hose Reels

For installation of hose reels on pressure washers.

Models: 16X664 and 16X665




Installation


- 1. Remove Hose Reel kit from packaging
- 2. Remove Pressure Washer Handle from the Pressure Washer Frame by removing the four bolts, nuts, and washers.



3. Position the Hose Reel Handle on the Pressure Washer Frame and re-install the four bolts, nuts, and washers. Tighten using wrenches (torque to17-20 ft lb.).



4. Connect the short Hose Reel pig tail hose with Quick Disconnect (QD) to Pressure Washer Pump outlet.




5. Remove female Quick Disconnect (QD) from 50 foot pressure washer hose.





 Route Pressure Washer Hose male 3/8 NPT end through Hose Reel opening and attach to 90 degree swivel fitting (orientation may vary depending on model - see images below). Rotate hose as you engage the NPT thread to prevent hose kinking. Tighten using wrenches. Guide hose onto hose reel.

 Connect male Quick Disconnect (QD) of other end of 50 foot Pressure Washer Hose to female end of gun.
